

Information for video surveillance system*pursuant to Art. 13 - 14 of GDPR 2016/679**pursuant to Order of 08/04/2010**pursuant to the Guidelines 3/2019***1. PROCESSING PURPOSE**

The Undersigned informs that a video surveillance system has been installed in order to protect property and people, or for safety at workplace and of corporate assets. The plant is already duly reported pursuant to Articles 13-14 of GDPR 2016/679 through suitable minimum information (sign).

2. PROCESSING METHOD

The personal data being processed are the images of natural persons that are processed in simple viewing; registration takes place by the Undersigned in accordance with the provisions of the Provision of the Privacy Authority of 08/04/2010 and the Guidelines 3/2019 and as reported in the authorization received from the territorial DTL.

The processing of the images takes place through computerized and automated tools; the intervention of specially authorized personnel takes place only in the event of technical anomalies or in the case of reporting to the police for events that have occurred and are harmful to the safety of property and people. To date, there are no "intelligent" devices, but simple video shooting tools.

3. NATURE OF DATA PROVISION

As a result of the establishment of the balance of interests and as a result of the purposes of protection and safety of property and people, to date, there is no requirement for your request for the provision of data. The processing is in fact necessary for the pursuit of the legitimate interest of the Data Controller as per Art. 6, paragraph 1, subpara. f of GDPR 2016/679.

4. DATA COMMUNICATION

The personal data processed, in any way, will be brought to the attention of specific external subjects.

5. DATA DISCLOSURE

The personal data processed, in any way, will be brought to the attention of indeterminate subjects.

6. TRANSFER ABROAD

The personal data processed will not be transferred abroad and/or outside the European Union.

7. RIGHTS OF THE DATA SUBJECT

You have the right to:

- know which personal data are processed by the Undersigned, their origin, the purpose and method of processing (Articles 13-14 of GDPR 2016/679);
- obtain the cancellation and/or destruction of data processed in violation of the law, as well as the updating, rectification or integration of data (Article 13-14 of GDPR 2016/679);
- submit a request for rectification to the Data Controller (Article 13-14 of GDPR 2016/679);
- propose a complaint to a supervisory authority (Article 13-14 of GDPR 2016/679);
- submit a request for cancellation (right to be forgotten) of the data managed by the Data Controller (Article 17 of GDPR 2016/679);
- submit a request for processing limitation (Article 18 of GDPR 2016/679);
- submit a request for opposition in cases where the processing falls within what is defined in Art. 21 of GDPR 2016/679.

8. PROCESSING DURATION

The conservation of the images will respect the time provided by Order of 08/04/2010 and by the authorization of the territorial DTL, or 24 hours. However, if the Data Subject deems, for any reason, the purpose of the processing to be exhausted, he/she must give written notice to the Data Controller indicated below, who will take action for the immediate cancellation of the information.

9. DATA CONTROLLER
